

## CONTEST RULES

### 1. HOW TO ENTER

No purchase required. This contest is open to residents of Quebec and Ontario and is governed by Canadian law.

By submitting an entry to the Contest, you signify that you have read the Contest Rules and agree to abide by them. You agree that submitting an entry to the Contest through the Website, or any other electronic platform, constitutes an electronic signature on your part, which binds you to these Rules.

Boxes on the form marked with an asterisk or otherwise indicated as mandatory must be completed in order to enter the Contest. Other information requested is useful, but is not required to enter the Contest.

Entries must be received by September 30, 2023, at 11:59 p.m. Eastern Standard Time to be eligible.

Limit one entry per email address, per person. Any person who enters or attempts to enter more than the permitted number of times, or who uses any robotic, automatic, mechanical, electronic or other duplication method not permitted by these rules, will be deemed to have tampered with or manipulated the entry, which will automatically void the entry, vote or any other results of that entry.

No entries will be accepted after the above deadline for any reason. Entries received after this deadline will be rejected.

## **2. ELIGIBILITY REQUIREMENTS**

Participants must be residents of Quebec and Ontario, 18 years of age or older.

The following people are not eligible:

- a. Employees of Roulottes Prolite Inc. as well as employees of Roulottes Prolite Inc. members during the Contest Period;
- b. Employees of the Sponsor/Prize Provider as well as their respective affiliates;
- c. Employees of the advertising agency organizing the Contest;
- d. Members of the immediate family of the above persons (father/mother, brother/sister, (including brother-in-law/sister-in-law, half-brother/half-sister), son/daughter) and those persons living in the same household.

## **3. WINNER SELECTION AND NOTIFICATION**

The Grand Prize will be drawn on Tuesday, October 1, 2024 at 1:00 p.m. by the Contest Organizers from all eligible entries received during the Contest Period.

The first entrant drawn to correctly answer the mathematical skill-testing question will be declared the winner, subject to fulfilling all the conditions set out in these Rules.

Each potential winner will be contacted by telephone, email or social media account at the number or information provided on the entry form or used to enter and must claim his/her prize as instructed by Roulottes Prolite Inc. within a maximum of seven days from the date and time he/she was first contacted.

In the event that a potential winner does not claim his/her prize within this time frame or answers the mathematical skill-testing question (if applicable) incorrectly, declines the prize or is declared ineligible, the prize will be automatically forfeited and Roulottes Prolite Inc. may, at its sole discretion, designate another potential winner, even if the potential winner's name has already been publicly announced. Cancelled prizes will not be awarded.

Roulottes Prolite Inc. may, at its sole discretion, require proof of identity or age from an entrant. Refusal to provide the requested proof will automatically result in the participant's disqualification.

#### **4. PRIZE DESCRIPTIONS**

#### **5. GENERAL CONDITIONS**

5.1. To be declared a winner, the participant selected in a draw must correctly answer a mathematical skill-testing question.

5.2. By entering the Contest, you:

a. acknowledge that you have read, accepted and complied with the Contest Rules;

b. confirm that you meet all the eligibility criteria for the Contest and accept the prize and take part in it (if you win);

c. provided you correctly answer the mathematical skill-testing question, accept the prize offered by Roulottes Prolite Inc. Sponsor/Prize Provider as awarded;

d. consent to the release of your name, city and province of residence, likeness, statements and/or voice and your entry to the Sponsor/Prize Provider and its use without compensation by Roulottes Prolite Inc;

e. and your heirs, successors and assigns release Roulottes Prolite Inc. and any Sponsor/Prize Provider and its/their respective affiliates, subsidiaries, directors, officers, agents, consultants, volunteers and employees (the "Contest Organizers") from any and all liability for any

In the event of a dispute or complaint that an entry violates these Contest rules, entries will be deemed to have been submitted in accordance with these Contest rules by the authorized account holder of the account used to submit the entry in question. 5.10. When the prize is awarded by vote, Roulottes Prolite Inc. reserves the right to cancel any vote deemed illegal or illegitimate and to make the appropriate adjustments in the calculation of the number of votes received by the participant concerned.

If it is determined by Roulottes Prolite Inc. that individuals are tampering with or misusing any aspect of the Contest, including, but not limited to, violating the Contest Rules, attempting to enter the Contest more than the maximum number of times permitted, or acting in a manner which is disruptive to the normal operation of the Contest, such individuals will be disqualified. Any person who enters or attempts to enter the Contest using robotic, automated, macro, or

Personal information requested on the entry form, such as name, age (if applicable) and contact information, is collected, maintained and used by Roulottes Prolite Inc. and the Sponsor/Prize Provider or their representatives for the purpose of administering the Contest as well as for any other purpose to which you consented at the time of entry. By providing your personal information, you expressly consent to the Privacy Policy. 5.18. In the event of a dispute as to the identity of an entrant, the authorized account holder of the email account at the time of entry will be deemed to be the entrant. The person who was assigned the email address for the domain associated with the submitted email address is deemed to be the authorized account holder. A selected entrant may be required to provide proof that he/she is the authorized account holder of the email account associated with the entry. All entries must be submitted from a valid email account that can be identified by a reverse domain name search. The time and date of the submission of an entry to the Contest, for the purpose of determining the validity of such submission, will be determined solely by the Contest server.

In the event of any discrepancy or inconsistency between these Contest rules and disclosures or other statements contained in any Contest-related materials, including but not limited to: the Website and/or point of sale, television, print or online advertising; the French language version of these Contest Rules and/or any instructions or interpretations of these rules provided by any representative of Roulottes Prolite Inc. or the Sponsor/Prize Provider or Roulottes Prolite Inc, the terms and conditions of this Contest regulation shall prevail to the fullest extent permitted by law.
